Respected Sir,

We are the residence of the above address since 23 years in a Government quareter.

On the night of 3rd May 2023, around 6 PM we got news that Kuki-Zo Tribals were attacked in Churachandpur District and in Checkon area, Imphal. We collected our important documents, laptop and other necessities and took shelter in our Meitei neighbor's house. We slept the night while our locality was ringing with sounds of cries, and smells of burning fires. As soon as morning arrived we went back to our home. Immediately, a red mark on our gate. When we entered the house, all our belongings are gone. Our furniture, our sofa sets, our kitchen items, our clothes, all of it was gone/stolen during the night of 3rd May, 2023.

Luckily our car Alto LXI, MN05A7717 was still there while our scooty pleasure 125 MN06SG5686, worth Rupees 1,15000 was stolen already, we got into our car and drove to the CRPF camp around 6 AM- 7AM on 4th May,2023. My neighbor drove the car while five of us, including my wife and three children got in the car with just the clothes on our back.

We spent 5 days at CRPF camp from the 4th of May, 2023 getting just enough food to survive. We then move to T.A. Camp at Malom where we were fed properly for the first time in 5 days. After spending 2 days at T.A. Camp, on the 11th of May, 2023 we manage to book flight tickets. It took us to Agartala and then to Guwahati Airport. We took a taxi to Shillong from Guwahati and arrived by Evening. We are staying at the MELC Pastor Quarters till date.
