Some volunteers helped us out and we moved to Regional Institute of Medical Sciences (RIMS) hospital where I work. From there, we were picked up by the Indian Army and moved us to Tulihal Airport, Imphal. We spent the night at the hospital and on the night of 5th May 2023, we had to sleep on the floor for one more night. Eventually, we boarded a flight from Imphal to Guwahati on 6th May 2023. On the 7th of May 2023, we moved from Guwahati to Shillong.
