Respected Sir,

I am resident of the above address since 2014. On 3rd May, Meitei mobs attacked our locality, burning houses and Church where we worship our Almighty GOD. We had to take shelter to CRPF Lamphel Camp. We were given some foods by the Army which could barely feed our hunger and the life we live were so miserable. We stayed there till 9th May 2023 and we were escorted to Imphal Airport by CRPF on 9th May 2023 and landed to Agartala. From there we moved to Shillong by road.

I was targeted because I am from Hmar Community and a Christian. Presently I don't feel safe about going back to my home because there is no safer place to take shelter and our life is at stake. I have an Activa 125CC in Imphal which were looted by the miscreants and all my household belonging amounting to Rs. 8.20 lakhs were also looted.

We are hoping for justice for us and all our people from this situation.
