Respected Sir,

I and my family were residing in the above address since February, 2001. On the 4th of May, 2023 we were ordered to move out of the house by the Arombai Tengol Miscreants or else they threatened that they would kill us. Hence we moved, under the protection of CRPF to 143 Battalion near DC office Lamphelpat, Imphal West 795004. On the 6th of May we flew to Guwahati and then to Shillong. Once we moved out of our house (which is a government Quarter), they looted all of our belongings by Meitei Miscreants.

My Family had to flee the state out of fear for our life as we belong to the Kuki Tribe. We had possessions including electronics, jewels, furnitures, clothes & dresses, and various other household materials worth Rs. 21,83,000 (approx) in our house which has all been looted and destroyed, and also one house plot in our locality which basically is a lost property as we will never be able to build on it in the near future.

Due to this incident I and my family have been put to great hardship and mental trauma. Hence, I request that you will investigate the matter and take proper action against the perpetrators as well as restore the situation to normalcy and provide protection for us to go back and re-build our lives back in our locality.

We are hoping for Justice for all who are in this plight.
