Respected Sir,

I and my family were residing in the above address since 12 years. On the dreadful day of 4th May 2023, we were ordered to move out of the house by the Arambai Tengol, miscreant or else they threatened that they would kill. Hence, we moved to the nearby Central Force Camp (namely CRPF) at Lamphelpat. A lot of victims of the Kukis seek protection there. As it is not safe to stay there any longer, we were moved to Kangpokpi with the help of N. Pratin Singh Hoikhoneng Haskip.

of the Army (convoy). As we were a family with three young kids, and the meiteis continues to burnt villages, we flee to shillong considering for our children and own safety. I had a possessions including electronics, my household items worth 50,000 in my house. And my house itself costed 35,000 and I have no idea if anything is left in my house.

Due to this incident I and my family have been put to great hardship and mental trauma.

Hence, I request that you will investigate the matter and take proper action against the perpetrators as well as restore the situation to normalcy. We request that you will also protect our properties and the whole locality from encroachment.

We are hoping for Justice for us and for all who are in this situation
