I have been staying in the above quarter
since 2020 with my son only as I am a
single mother. On 4th May we were stranded in
CPPT camp as there was no violence
against kuki in Manipur. I had to leave
everything behind for my safety. We had
fled to Shillong and reach on 8th May 23.
My house has been looted and damaged
on 14th May 23. I am left with nothing.
The property or possession which I lost
is about 6-7 lakhs which is a lot for
a mere LDC. I have bought all the things
with my hard earn money. Relocation and
my son school re-admission is costing a lot.
Kindly compensate the lost about 6-7 lakhs.
