Respected Sir,

I and my family were residing in the above address for the past 5 years. On the 3rd May 2023 we were ordered to move out of the house by the Aizawl Tengel and Meitei Leepun, threatening that they will kill us if we don't. On 4th May 2023 in the early morning I along with my family flee to the nearby CRPF camp opposite to Imphal West DC office. After staying for few days in CRPF Relief camp we fly to Shillong from Tuithan Airport. on 7th May 2023.

I had to flee since I was a Kuki, we still fear for our lives. I am serving in Manipur Police Dept. posted in Bishnupur Dist. and now I don't know when can I go back to my job or if my salary will continue to be paid. I had possessions including electronics, vehicles and Jewels worth 45,00,000.

In Manipur we used to buy Govt. Quarters to the previous occupant so, I bought my Quarters at 450000/- and I spend 300000 in renovation. On 4th May while moving towards CRPF Camp we were block by the meitei Radical groups Anambai Tengol and meitei Lupin, we were force to move by foot after reaching the CRPF relief camp we heard that all our stranded vehicles were burnt down. All my belonging were looted.

Due to this incidents me and my family have been put to great hardship and mental Trauma.

Hence, I request that you will investigate the matter and take proper action against the perpetrators as well as restore the situation normal.

We are hoping for justice for all who are in this situation.
