Sir,

I, the undersigned, have the honour to state few line for kind consideration and necessary action please.

That, today i.e on 26<sup>th</sup> Sept 2023 at around 3:40 am, while a team of C/99 Bn. RAF/CRPF led by me conducted frisking and checking at the main road of Langol Housing Complex, Type-III, near Langol Chingmee Yammee Nupee Yaiphal Thourang Lup, 2(two) unknown vehicle Bolero Pick up & Tata Winger bearing Regn.No. MN01G-5309 driven by unknown drivers with 3( three) occupants coming from Type-III, carrying furniture items over the top of the vehicle in a suspicious manner. The unknown two four-wheelers vehicles were intercepted at the check point. On checking the vehicle (Tata Winger) having Regn No. MN01G-5309 and Bolero Pick up bearing MN0GLA-0460 were detained for verification. On verification they identified themselves as (1) Leimapokpam Basanta Singh (41) S/o (L) L. Ibohal of Churachandpur Khuga Tampak, PS Churachandpur A/p Langol Relief Camp (2) Khundongbam Manojkumar Singh (30) of Sugnu Meisnam Leikai, PS Sugnu, District Kakching A/p Langol Relief Camp (3) Kayenpaibam Indubala Devi (48) W/o K. Shingajit of Torbung Bangla Maning Leikai, PS Moirang Dist: Bishenpur A/p Langol Relief camp (4) Leimapokpam Ibema Devi (40) W/o L. Basanta of Churachandpur A/p Langol Relief Camp and learnt that they took the furniture items from the abandoned or deserted houses of Kuki located at Phaipijang. Later the driver and occupants were arrested on the spot at 4:00 am in presence of a lady RAF/CRPF - C/99 and the furniture items and other household items including the 2(two) four wheelers were seized at 4:15 am by observing formalities.

The arrest accused persons along with the seized items are handed over to you for further legal proceeding.
