Subject: - Report.

Sir,

I have the honour to state that today i.e., 26/09/2023 at about 08:45 am, received a reliable information from 4-AR and further corroborated from our own source about the presence of some arms and ammunitions at Shija Road area. Based on the information, a combined team of a column of 4-AR and a team of CDO-IW led by Inspector P. Achouba Meitei, OC-CDO-IW and myself under the command of Shri M. Amit Singh, MPS Addl. SP(Ops.) IW and under the supervision of Shri Dr. S. Ibomcha Singh, MPS, SP-IW rushed to the said area and conducted search at the stretch of Shija Road. During the search, the said team recovered the undernoted articles which were found abandoned at the southern road side of Shija Road near Imphal City Sewage treatment plant:

- i) 1 (one) no. of 5.56 mm AMOGH Carbine marked with "AMOGH 5.56 mm No. AA 1245 IN S.A.F. 2011" bearing body no. AM1540 along with 3 (three) nos. of empty magazines and
- ii) 4 (four) nos. of HE 36 Hand Grenades without detonator.

Hence, the above recovered articles were seized from the spot at 09:30 am by observing formalities.

Hence, the seized articles are handed over to you for taking further necessary legal action.
