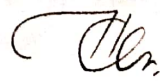

Sir,

With due respect I would like to state that on the 4th of May 2013
Our house in Nepali Basti, opposite Kiddle's Corner School, Chingmeirang Imphal had been attacked by a mob in hundreds. They started pelting stones and started to burn our neighbour's garages and house at about 2:00 pm. We then had to flee for our lives as we are the next target. We could only escape with the personal clothes on our body and were rescued by the 69 bn CRPF. Before we were rescued by the CRPF we had

running in the nearby school by 40
time the mob started burning our
garage and servants quarters in front
of the house. Then they started
vandalizing our house and looted
every items and belongings inside
the house which includes the
