Sub: - Complaint report of vandalizing, looting of properties and burning down at
Hebron Veng, Phaipijaang, Imphal West district, Manipur - regarding.

Sir,

I am to report that on the intervening night of 3rd & 4th May, 2023 a huge number of unruly persons armed with deadly weapons like sticks, iron rods, daos, catapults, inflammable materials, etc. stormed our roadside compound at Hebron Veng, Phaipijaang Village of 91-Meitei Langol, Imphal West (under Lamphel Police Station, Imphal West) by completely destroying the fencing and vandalised and looted both the hotel/dukan and the residential houses. After which, they set on fire both the houses along-with whatever were remaining in the two houses and reduced everything into ashes.

The destroyed/looted/burnt included:

- i) Commercial plot of size 110'x90', having a value of more than Rs.2,50,00,000/-
- ii) The tea hotel house, all items, utensils, with furniture and 2 (two) gas cylinders with stove, potted flowers for sale, floriculture implements and manures & store wares, etc.
- iii) One residential house along-with all household items - furniture, clothes/clothings, utensils, wooden almirahs & trunk boxes with valuables, books and records, implements, etc.
- iv) 1(one) Auto Rickshaw, one bi-cycle, 2(two) water storage tanks, etc.

The total lost of property including the plot is estimated at around Rs.2,80,00,000/-

The said incident could not be reported timely as we could not venture out in Imphal due to the serious threat on our lives and as we fled our home on the 6th May, 2023 by flight to Guwahati, which was the only option available to leave Imphal for the safety of our lives.

I, therefore, submit my complaint/report to you with a request for registration of a Zero FIR
