Dear Sir/Madam.

I, Vunghoisiam Vaiphei W/o T.H Hangshing, aged about 30 years and resident of Kangchup, Chingkhong Village, Kangpokpi District - 795146 would like to make a report that occurred due to violence that swept across Manipur.

That on 4th May 2023, around 11 AM, everyone was asked to take temporary shelter at any nearby Army/CRPF Camps. As such, my father-in-law Mr. Henpimang Hangshing and my uncle Mr. Thangvendam Hangshing also drove their respective vehicles towards a 143 BN CRPF Camp, near DC Office, Imphal West. On the way, some Meitei mobs suspected to be volunteers of Arambai Tenggol and Meitei Leepun holding lathis, Iron rods and sophisticated weapons forcefully stopped them in front of the Exchange Office. The victimized people including both men and women were threatened and were forced to vacate the area and leave the cars behind.

At around 2 PM, the Meitei mobs, suspected to be a volunteer of Arambai Tenggol and Meitei Leepun, push down the vehicles beside the road and later burnt down the vehicles. This incident occurred near the Employment Exchange Office, Imphal West which falls under Lamphel Police Station, Imphal West, Pin No. - 795004.

I request you to kindly register a Zero FIR as I couldn't file a complaint at my home town. Thank you for your attention to this matter.
