Sir,


With reference to the captioned subject, I bring to your notice that on the morning of 4th May 2023, at around 10.00- 11.00 a.m, a group of riotous mob open the gate of my leased rented accommodation located at Changangei Ucheckon, Imphal West (House of Sh Chinkhokam Hangshing). The house was set on fire and my house-hold belongings and vehicles were looted, ransacked and set ablaze. Further, mobile phone and personal documents such as Aadhar cards, Voter ID cards, educational certificates etc of self and my family members were also snatched by the mob.

The brief details of my losses are as under:

01. Mahindra XUV 300 no MN01AS 8096 (4-Wheeler)- Approx Value 11.00 Lakhs
02. Yamaha Scooty no ML05L 0240 (2-Wheeler)- Approx value 0.25 Lakhs

 - i) Educational Qualification certificates of Hubert S.Z Khobung (HSLC, P.U, Degree to MSc) and Rebecca Rodinglien (spouse) (HSLC, HSSLC and GNM)
 - ii) Birth Certificates of Self, Spouse and Children (Obad Lalmalsawma (son), Maria Lalsangpuii (daughter) and Felix Lalsandam (son)
 - iii) Voter ID cards of self and spouse v) Aadhar cards of self, spouse and children
 - iv) Life Insurance Policies of self, spouse and children as under:
 - a) SBI Life Insurance policies no. 17003991401, 17003981109, 45403296310, 50023365306, 45470908302 and 2Q491686810
 - b) LIC Policies no 401557573, 401557572 and 449818814
04. Jewellery (silver coins and gold ornaments) – Approximate value 3.00 Lakhs


