Sir,

I have the honour to report to you for kind consideration that, due to unavoidable circumstances I cannot report on time. However, I humbly request for your kind entry and look into the matter.

That, on 4th May, 2023 around 08:00 AM thousands of mobs from the Meitei community carrying deadly weapons, attacked and ransacked my rented houses at Khongsai Veng, Laipham Khonou, Imphal East. And they also looted all my household properties.

**Details of destroyed houses/looted items:**

(Rented house) Refrigerator, Washing machine, Drawer-2, dressing table, Study table -3, Trolley bag-3, Jumbo Box-2, Bed-4, Gas stove, Cylinder-3, Dining table (large), chair-9, Grinder, Syntex 1500 Litres-5, Gas Box, Dressing hanger, Blanket (large) - 5, Electric guitar (schecter sun valley), Lenovo Laptop, Amplifier (Yamaha), Audio interface (scarlet), Acoustic guitar, Apple MacBook (Air 2020), Tailoring Machine, Vespa ZX bearing Registration No. MN06SG6069. All valuable/invaluable items in the households were completely looted or either destroyed.

The approximate value of total losses in ₹ 15,00,000/- ( Rupees Fifteen lakhs)

I therefore request to book the culprit and take necessary action as per the law of the land.
