However, during the said period my rented house was attack and burnt by unknown miscreant, in the melee all my School/college documents (i.e Class X Original certificates; Admit Card, Marksheet, Provisional, Character, transfer bearing Roll No. 26186 under BOSEM, XI Certificate; Admit Card, Marksheet bearing Roll No. 16631385, and XII original certificates; Admit Card, Marksheet, Provisional, transfer, character bearing Roll No. 16631385 under CBSE and B.A 1^{st} , $2^{nd},\,3^{rd}$ & 5^{th} Admit Card & Marksheet bearing Roll No. 20206712 of Liberal College, Imphal and Registration Certificate under MU were also burnt to ashes render me unable to continue my further studies.

I therefore request to you to kindly enter an FIR in order to further process me to apply for new (duplicate) certificates at the concerned authority.
