Sir.

I have the honour to state that, on 04-05-2023 at around 3:15 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000-2000 persons carrying sophiscated weapon like AK Rifles, SLR, INSAS and .303 Rilfes, forcefully entered our locality, Khongsai Veng, Laipham Khunou, Imphal East, 795010 and they vandalised and looted all the valuable and moveable household properties and they also burnt down my house including 1(one) two wheeler vehicle Activa bearing regd. No. MN-01 3217 alongwith insurance & other relevant documents, leaving us homeless. The list of properties destroyed or loss including the land assessment value is refered in the annexure (enclosed). The approximate value of lost property is calculated at about R. 3,47,95,000/-(Three crores forty seven lakhs and ninety five thousand)

Due to the aggravation of communal tension in the state and lack of legal knowledge I colud not report to the concern Authority in time.

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
