Subject - Report on crimes of vandalism, looting, criminal intimidation, unlawful displacement and discrimination of Scheduled Tribes.

Dear Sir.

With reference to the above cited subject, I have the honour to report to you as follows:

That, I am a Scheduled Tribe belonging to the *Hmar Tribe*, which is a recognized Tribe under the Constitution of India, by virtue of which I am being entitled to the protection under The SC/ST (Prevention of Atrocities) Act, 1989.

That, due to the prevailing ethnic crisis in and around Imphal, we left our permanent resident located at Spring Villa, Phaipijang, Langol Village, P.O.- Langol, P.S.- Lamphelpat and District-Imphal West-795004 on the 4th of May,2023 at around 11.15AM, taking refuge at Central Reserve Police Force (CRPF) Camp, Lamphel. It came to our knowledge that our deserted resident was looted and vandalized by a group of Meetei/Meitei miscreants suspected to be members of Arambai Tenggol and Meitei Leepun on the 8th of September,2023 at around 11:00 AM.

The criminals broke open the door, destroyed and looted every valuable property from the said resident worth about Rs.41,39,700/- (Rupees Forty-One Lakhs Thirty-Nine Thousand Seven Hundred) only.

That, it may be reported here that the miscreants were shouting slogans like- "KANGLEIPAK YAIPHARE"; "KUKI HATLO"; "HAO HATLO"; etc. while they were carrying out their criminal activities. It seems to me that all these has taken place at the instance of the Manipur State Government as the perpetrators openly claimed and shouted that nobody would stop them, even the police because everyone, including top officials of the Manipur Government are patronizing them and that that no harm could be done to them.

In the given circumstances, I humbly pray you to kindly register my case, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of our country. And, for which act of kindness, I shall always remain thankful to you and obliged. Thus, I am filing the report today.
