Sir,

I am to bring to your kind notice that I am a Scheduled Tribe (Kuki/Zo) and a resident of National Games Village Zone 1 C-71.

That, on the 3<sup>rd</sup> May, 2023 at 6:30 AM my above said residence "Owned/Rented" was attacked, destroyed and looted by a Group of Meitei/Meiteis radicals.

As I had left my residence with my family on the above said day and could not take any of my belongings. These criminals broke/open my gate(s), destroyed and looted every valuable property from my residence and premises worth Rupees 8,86,000 (Approx.)

While carrying out their said criminals activities; the said Meitei radical groups were shouting anti-tribal slogans.

I, therefore, request you to kindly take strong actions against the perpetrators by registering an **FIR/Zero FIR** under relevant sections of Law.
