Subject: Report on loss of transformer oil from 400kVA, Lamboi Khongnangkhang on 17/10/2023 between 1.00 am to 2.30 am.

Sir,

As reported from the local Club viz. Office of the United Friends Library & Club, Lamboi Khongnangkhang, it is stated that transformer oil of 1x400kVA DTR located at Lamboi Khongnangkhang opposite to Manipur Trade and Expo Centre was stolen last night by some unknown person. On inspection at site by our staff, it is found that no oil was left inside the transformer which is approximately 2 barrels amounting to Rs.60,000/-(approx.). The transformer power supply has been cut off to avoid burnt out of coils and insulations.

Therefore, it is requested you to kindly register an immediate FIR and take quick action against the culprit.

Hope you will do the needful at the earliest.
