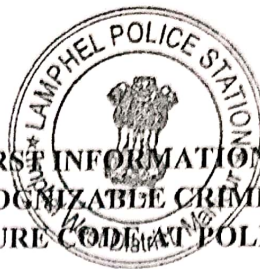

with due reverence, I the undersigned have
the honour to state a few facts for your kind
consideration. That, Today, on Date 2nd Oct. 2023,
around 4:30 AM, my residence was burnt down
completely by the unknown miscreant this morning,
at happy valley, National games village (NGV), Mitai
Langol, Imphal - west District, Manipur, while the
prevailing situation of ethnic conflict is still
going on in Manipur.

The following are lost while burning down
with approximate amount:

- 1) Semi-pucca House — Rs. 30,00,000/-
- 2) Household utensil — Rs. 5,00,000/-
- 3) Furniture — Rs. 6,00,000/-
- 4) Traditional clothes and dress — Rs. 5,00,000/-
- 5) Documents and Certificates — Rs. 50,000/-

G.T. = Rs. 46,50,000/-

(Forty six Lakhs and fifty thousand) only
