



Subject: - Report.

Sir,

I have the honour to state that today i.e. 21/10/2023 at about 10:10 am received a reliable information about the presence of some active cadres of PREPAK (PRO) organization an outlawed banned organization in and around Lamphel Super Market area. Acting on the information, teams of CDO-IW led by Inspector P. Achouba Meetei, OC-CDO-IW and myself under the command of Shri M. Amit Singh, MPS Addl.SP(Ops.) IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted a search operation at the said area. During search at one rented house located at Lamphel Super Market owned by one Kh. Bablu S/o. Kh. Tomba of Pishum Ningom Leirak, one unknown person was found in a bed room of the said rented house in a suspicious manner. Due to his suspicious manner he was detained for spot verification and checking. During spot body search, the following articles were recovered from his possession : (i) 1(one) Vivo Y72 5G mobile handset along with 2(two) SIM cards i.e. (a) one JIO SIM card bearing no. 89918640400254467207 (Ph. No. 7499705309 as disclosed by him) and (b) one Airtel SIM card bearing no. 8991160990022921391U (Ph. No. 8132912113 as disclosed by him) and (ii) 1(one) Cellegor mobile handset along with 2(two) Airtel SIM cards bearing numbers i.e. (a) 8991160990021668905U and (b) 8991160990020863840U (Ph. No. 9233277930 as disclosed by him). During searching of the bed room, 1(one) 9mm pistol along with 1(one) magazine loaded with 5(five) rounds of 9mm ammunitions, 1(one) Aadhaar card and a sum of Rs. 5000/- (Rupees five thousand only) were also recovered under his pillow.

During spot verification, he identified himself as Shyam Huidrom Singh (45 yrs) @ John @ Max S/o. (L) H. Yaima Singh of Khagempalli Huidrom Leikai, Imphal West District. On preliminary verification, he disclosed that he is an active member of PREPAK (PRO) organization and started working for the said organization since July, 2023 under the command of one s/s commander Hallakpa (Ph. No. 8798330987) of PREPAK (PRO) organization who is working under Erei of PREPAK (PRO) organization. He further disclosed that as per the instruction of his commander (Hallakpa) he received a sum of Rs. 60,000/- (Rupees sixty thousand only) from one unknown person at RIMS Gate and the same amount of money was later handed over to one unknown person sent by his commander 10 (ten) days back for their party fund. Further, he disclosed that under the instruction of his commander he received a sum of Rs. 1,20,000/- (Rupees one lakhs twenty thousand only) from one unknown person and the said amount of money was later handed over to one unknown person sent by his commander at Canchipur Main Gate 7(seven) days back. He also disclosed that he received the above recovered amount of money i.e. Rs. 5000/- (Rupees five thousand only) as monthly monetary assistance from his commander 4(four) days back. He also disclosed that on 19/10/2023 at around 11:00 am he received one Honda Activa 6G blue in colour bearing registration number MN01 AJ 5496 (without any valid documents) from one unknown person sent by his commander near Oil Pump located at Andro Parking for using in their party activities and the same Honda Activa was found parked in front of the said rented house and was later recovered.

On asking about the above recovered 9mm pistol, he disclosed that as per the instruction of his commander he collected the said 9mm pistol which was found hanging at the back side of a closed shop located in between Khongjom and Langathel area around 15(fifteen) days back.

Hence, he was arrested from the spot at 11.00 am and the above recovered items were seized at 11.20 am from the spot by observing formalities.

Therefore, the arrested person along with the seized articles are handed over to you for taking further necessary legal action against him.
