Sir,

As per endorsement vide GD entry no. 28/LPS/2023, Dated 17/10/2023 I have enquired into the matter and the fact of the case is that on 17/10/2023 one Haji Md. Taher Ali age 75 yrs S/o Late Nasir Ali of Lilong Uku Maning lodged a complaint report to The Officer In-Charge Lamphel Police Station stating that while he along with his son namely Akil Ahmad(32) were at the RIMS gate in order to get medical treatment of him. At the same time, his son-in-law namely Haji Md. Karimuddin aged about 52 yrs S/O Late Md. Rahimuddin of Liong Turel Ahani Ubak Thong Mathak and his associates had forcibly picked up them on a Mahindra Thar Jeep registration number not known on gun point and took them to an unknown place, later known the place as Leimakhong Kanto Leikai. At the said place, they kept concealed his son at a room and him outside the room. Thereafter, he (Karimuddin) started assaulting his son with an intension to kill and also took his son signature at a blank paper and on an affidavit/Order sheet. Moreover, Karimuddin also took a signature as declaration of his son to neither die himself if he took revenge nor make any complaint to any police station against Karimuddin the matter. Lastly, Karimuddin also took video coverage of him and his son while signing the documents. Hence the enquiry.

During the course of enquiry I have examined the complainant namely Haji Md. Taher Ali (75) thoroughly and he fully corroborated with the report file by him. On examination he stated that on dated 17/10/2023 he along with his son Md. Akil Ahamad came to RIMS hospital by driving one two wheeler, Honda Access for medical check up on communicating with his son in-law Haji Md. Karimuddin telling that Karimuddin will book the OPD Ticket first. On reaching at RIMS gate Md. Karimuddin told to come near his vehicle Thar Jeep and took the ticket. While his son Md. Akil went near Karimuddin some 4 to 5 unknown persons forcibly picked up him along with his son Akil Ahamad on the Thar Jeep. He along with his son, son in-law and one unknown person boarded on the Thar Jeep and drive towards Eroishemba via Langol accompanied with one Gypsy. Then, Md. Karimuddin and unknown person took to one unknown house taking his son Akil inside the house and he was make sited on the Thar Jeep. After a while he heard a sound of assaulting his son Akil inside the room, on hearing he tried to intervene but the unknown persons stop at the door. Later, his son in-law(Karimuddin), Akil and unknown persons came out from the room holding some paper by Md. Karimuddin. Md. Karimuddin forcefully took his son Akil signature at a blank paper and on an affidavit/Order sheet with video coverage. Later, he and his son Akil was drop about 2 km from the unknown house by unknown persons.



On examination of Md. Akil Ahamad(32) S/O Haji Md. Taher Ali he also stated the same version of the fact of the crime. He was taken inside one unknown house room by 2/3 unknown persons and inquired about his role in family relation in between his elder sister and Md Karimuddin. In between Md. Karimuddin came inside the room and said "Statement phajana lou" "ma ngasi loishanladabani" and he went out of the room. After sometime he (Karimuddin) came again and stated assaulting him, kicking on the chest repeatedly. Later, he and his father make a shit on the veranda of the house and forcibly took his signature on blank paper, affidavit and order sheet. Md. Karimuddin also forcibly took his signature on TALLAK NAMMA with his elder sister Phundreimayum Miskatun Nesha. After he and his father drop for about 2 km and he reach home by driving his Honda Access. On reaching at his house at Lilong he got unconscious and evacuated to hospital by his family members.

On further course of enquiry I have submitted an injury report of the injured person Md.Akil Ahamad of Lilong at Public Hospital & Research Institute, Hatta Minuthong for opinion of the cause of hurt and the opinion of the doctor is still awaited. Further, I have tried to cause examined of the accused person Haji Md. Karimuddin (52) S/o (L) Md. Rahimuddin of Lilong Turel Ahanbi Ubak Thong Mathak by serving a summon to dig out the real fact of the case but fails to appear before the PS.

In view of the above fact and circumstance of the case, I have the honour to kindly take further necessary action against the accused persons.
