Sir,

I have the honour to state that today i.e. 30/10/2023 at about 03:00 pm received a reliable information from our own source about the presence of some active cadres of KCP organization in and around Tera Bazar area with a view to commit prejudicial activities like extortion of money from the general public etc. Acting on the information, teams of CDO-IW led by Inspector P. Achouba Meetei OC-CDO-IW and myself under the command of Shri M. Amit Singh, MPS Addl.SP(Ops.) IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted cordon and search operation at Tera Bazar. During that, one person was found standing near one TVS Jupiter scooter brown in colour at Tera Sapam Leirak Machin in a very suspicious manner. Due to his suspicious nature, he was detained for spot verification and checking. On spot body search, the following articles were recovered from his possession: (i) 1 (one) Samsung Galaxy A33 5G mobile handset along with two Airtel SIM cards bearing no. (a) 8991160990007533298U (Ph. No. 6909459527 as disclosed by him) and (b) 0523 1D 8991160990023431377U (Ph. No. 8131805428 as disclosed by him), (ii) a sum of Rs. 50,000/- (rupees fifty thousand only) inside the front right side pocket of his pant and (iii) 1 (one) wallet black in colour containing 1 (one) Aadhaar card and Rs. 540/- (rupees five hundred forty only).

During preliminary verification, he identified himself as Laithangbam Robert Singh @ Abu (29 yrs.) S/o. (L) L. Ronal Singh of Uripok Sorbon Thingel. On further verification, he further disclosed that he is an active member of KCP (City Meitei) organization and started working for the said organization since May, 2023 under the command of one s/s commander Mr. Bedakumar Sharma @ Thoibi from Tera Lukrakpam Leikai of KCP (City Meitei) organization (9863445567). He disclosed that under the instruction of his commander, he made monetary demands and extorted huge amounts of money including the above recovered amount of money i.e. Rs. 50,000/- from several businessmen, shops and general public in and around Imphal area for their party fund. He further disclosed that the above mentioned TVS Jupiter scooter brown in colour bearing regd. no. MN06SD 9719 was used in their party activities.

Hence, he was arrested from the spot at 03:50 pm and the above recovered articles along with the above mentioned TVS Jupiter scooter brown in colour bearing regd. no. MN06SD 9719 were seized at 04:00 pm by observing formalities.

Therefore, the arrested person along with the seized articles is handed over to you for taking further necessary legal action against them.
