Sir,

I have the honour to lodge this complaint for the looted of following items/particulars by nearly 50 to 60 unknown miscreants during Meitei and Kuki clash on the period of 5 days from 8th May to 12th May, 2023 while my family members were at Iroishemba. When I came back to my Quarter on 12th May, 2023 at around 7 pm I found my items/particulars were looted.
