



I am to state that me and my family have been forced to leave my Government allotted residence G/III-64, Langol Housing Complex, Imphal, Manipur on 4<sup>th</sup> May, 2023 due to the ongoing communal conflict.

My residence have been looted and our vehicles i.e., (i) Maruti Suzuki Celerio ZXI, Color (Glistening Grey), Body type: Rigid (passenger car), Registration No. MN01AW-1318, Chassis No. MA3TFC62SNE157174, Engine Motor No. K10CN1020184, Date of Registration - 2 July 2022 valid up to 1 July 2037 (registered in my name) and (ii) TVS Jupiter (T-Grey Colour), Registration No. MN01AF-1347, Engine No. EG4GJ1418621, Chassis No. MD626EG41J3G89295, Date of Registration - 16th November 2018 (registered in my husband's name) which were left behind at our residence, had been taken away along with all my household stuffs on 30th October, 2023 by unknown miscreant(s).

I request you to acknowledge that the above-stated vehicles are no longer in my custody and control so I cannot be held liable for any misuse of the vehicles. I, therefore, request you to kindly look into the matter and take necessary action at your end.
