I have the honour to state that today i.e. 25/11/2023 at about 5:00 am, received a reliable information about the presence of some active cadres of PREPAK organisation an outlawed banned organization in and around Sagolband Tera Khuraijam Leikai area with a view to commit prejudicial activities like extortion of money from the general public etc. Acting on the information, teams of CDO-IW led by Inspector P. Achouba Meetei, OC-CDO-IW, and myself under the command of Shri M. Amit Singh, MPS Addl.SP(Ops.) IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area and conducted cordon and house search operation at Sagolband Tera Khuraijam Leikai. During that one unknown person was found in a very suspicious manner in the house of Konthoujam Ibotombi Meitei. Due to his suspicious nature, he was detained for spot verification. On spot body searched 2 (two) mobile handset i.e. (i) one Nokia mobile handset model no. TA-1473 along with one Airtel SIM card bearing SIM no. 0223 ID 89911609900022975520U (Phone No. 6909400757 as disclosed by him), (ii) one Redmi K20 pro mobile handset along with one Jio SIM card bearing SIM no.89918650400112112398 (Phone No. 7005244098 as disclosed by him) and one wallet containing one Aadhaar card were recovered from his possession.

On spot verification, he identified himself as Konthoujam Chaoba @ Punshiba Meitei (42 yrs.) s/o. (L) Konthoujam Ibotombi Meitei of Sagolband Tera Khuraijam Leikai. On preliminary questioning, he disclosed that he is an active cadre of PREPAK organization and joined the said organization in the year 2010. Further, he disclosed that he got basic military training in the year 2010 at Taka, Myanmar and allotted Army No. 3212147 of 35th batched, presently he is holding the rank of Lance corporal of PREPAK organization. He also revealed that he is presently working under the command of s/s Lt. Mr. Tomba of PREPAK organization. He disclosed that under the instruction of his commander, he made monetary demands and extorted huge amounts of money from several businessmen, shops, private schools and general public in and around Imphal area for their party fund and the said extorted money were handed over to one unknown person send by his commander. Hence, he was arrested at the spot at 6:00 am and the above recovered articles were seized at 6:10 am by observing formalities.

It is, therefore, the arrested person and seized articles are handed over to you for taking further necessary legal action against him.
