I, the undersigned would like to bring forth to your knowledge and report that I, am a permanent resident and native of National Game Village, Zone 1, D/110, Village, P.O.&P.S. Lamphel District Imphal West, Manipur and that some armed radicals belonging to the Meitei/Meitei community broke open my rented/residential home and vandalized, looted and all what is within and along with the house was lost to the said meitei/meitei armed radical groups illegal activities a total loss estimated to be at an amount of Rs. 10 lacs fifteen lakhs Only.

Fortunately, me and my family managed to escaped from these criminals who even tried to kill or burn us alive, and now currently taking refuge at, Shillong, Assam Bazar.

Therefore I kindly request you to please take action in this matter and come up with positive solution.
