Subject: Report on lost of movable and immovable properties.

Sir,

With due respect and humble submission, I beg to state that on 03-08-2023 at around 03:00 PM some unknown miscreants armed youth suspected by meeitei Youth organization Arambai Tenggol meeitei leepun and kangleipak kanba lup (KKL) numbering about 1000 member carrying sophisticated weapons like AK Rifles, SLR forcefully entered my colony Langol phaipijang, PO - Lamphel, PS - Lamphel, Imphal West district, Manipur. After looting all the properties, the house was also dismantled.

The details of properties lost are as follows:

Residential house, Bed (4), Almirah (4), Drawer (3), Dress Rag (3), Shoes rag (5), Sewing machine (5), Jumbo box (6), Table (4), Arm bench (5), Tv stand, Smart TV, Battery, Dining table, Cloths, Traditional shawls (30), Fridge, Gas stove, Cylinder (3), Utensils almirah, Sintex (3), Kitchen items, Dog (3), Duck (20), Shop Building, Shop materials, Blankets, Mattress.

The total worth of the properties was estimated to about Rs. 60,00,000 (Sixty lakhs)

I request you to kindly register the case and take necessary action according to law.
