With due respect, I have the honor to lay down few lines before you for your kind consideration and necessary action.

That, on 4th May 2023, I along with my family have left our home to a safety place due to the attack on Kuki community at Langol area by Meitei community led by Arambam Tengol and other extremist volunteers.

That, on dated 4<sup>th</sup> August 2023 at @ 9:00 pm, miscreants from Meitei community after breaking into my residence at Langol Phaipijang Gamngai Veng, PO/PS Lamphel, Imphal West District Manipur have vandalized my house and Chongthu Baptist Church, Langol Office set up inside my residence. The miscreants have burnt down my house and property worth Rs. 60 Lakhs and also the Office of the Chongthu Baptist Church, Langol set up inside my residence campus along with all important documents and property worth Rs. 30 Lakhs. The total amount of property lost and burnt down is estimated at Rs. 90 Lakhs approximately.

I could not report the incident to the concerned Police Station in time due to the prevailing law and order situation in the state.

I, therefore kindly request your good Office to kindly take up necessary action in this regard.
