With due respect, I would like to inform you that on 3rd September 2023 at around 2:00 pm some valley-based organisations to be volunteers of Arambai Tenggol, Kangleipak Kanba Lup (KKL), Meitei Leepun, broke into my residential quarter at National Games Village, D-64, Zone-1 with an attempt to kill us and loot all my household properties however I along with my family have left my quarter on 4th May and took shelter at CRPF Camp Lamphel. The volunteers looted all my household properties worth approximately around Rs.13,09,000/-(thirteen lakhs nine thousand) only, which includes all household properties and electronic gadgets. My Maruti Alto Car bearing Regd. No. MN02B-5316 which was parked between National Games Village and CRPF Lamphel was also burnt down by the suspected volunteers of the above organisation.

I therefore request you to take up necessary legal action regarding the incident.
