**Subject:** FIR on Destruction of Khongsai Veng, Imphal House no. 165 on 4<sup>th</sup> May, 2023 at 3:00 pm by the valley base miscreants.

Sir,

I am to state that, on 4<sup>th</sup> May, 2023, at around 3: 00 pm, our Locality Khongsai Veng Laiphamkhunou, under Lamphel Police Station, (Imphal West and falling under revenue of Imphal East) was under mob attacked by thousands of unknown miscreants belonging to the Meitei community with an intend to murder.

As a result, many houses and properties worth crores were destroyed and burnt to ashes. My house No. 165 ( Permanent Residence) was also destroyed by the mob, many properties were burnt and leftover looted.

1. Immovable properties like house having house rent pucca building
2. Movable properties
  - a. Documents : School Certificate, Office Certificate and others Etc.
  - b. Furniture : 2 Sleeping beds, 15 Almirah, 1 Dressing Table, 1 Gas Box, , 4 Arm Chair.
  - c. Electronics : 1 Desktop, 1 Laptops, 1 Washing machine, Solar & Inverter, 2 Smart TV, 2 Tablets
  - d. Gold & Jewelers : 5 Gold Necklace, etc.
  - e. Traditional Ornaments: 95 Traditonal ornaments
  - f. Modern and traditional Garments: 120 Pieces
  - g. Gas Book : 5 Cylinders, 1 Gas Book, 1 Gas stove
  - h. Cash : 3 lakhs

Total loss of properties at my residence would be above Rs 2500000 ( Rs 25 Lakhs )

It is therefore kindly requested to take necessary legal action to arrest the culprit involved in the incidents at the earliest in the interest of justice, I hereby lodged my complain at Kangpokpi police station as I had fled my residence to save my families from the rioters.
