I, Mrs. Veronica Lamhoithem wife of Mr. Kamgoulen Chongloi, residing at Langol Phaipijang, am writing to file an FIR regarding a grave incident that occurred on the 4th of August 2023 at around 2:00 PM. The incident took place at Langol Phaipijang village, which falls under the jurisdiction of Lamphel Police Station.

On the aforementioned date and time, a large mob of Meitei miscreants, numbering in the thousands, violently attacked our village, Langol Phaipijang. They engaged in a series of criminal activities that caused widespread chaos, fear, substantial damage and looted to our properties moveable and immovable assets. This horrific incident has left our community traumatized and in a state of distress. We believe it is imperative to bring the culprits responsible for these heinous acts to justice.

I hereby request you to take immediate and necessary action to investigate this incident thoroughly. I am willing to cooperate fully with the police in providing any information or evidence that may aid the investigation process.

I kindly request the following actions be taken:

- 1. Promptly initiate an investigation into this incident to identify and apprehend the individuals responsible for the attack, looting, and vandalization.
- 2. Recover the stolen properties and compensate the victim for the losses. I have enclosed an Annexure listing the properties that were looted or destroyed during the attack for your reference.
