

That me and my family have been settling at Langol Vaiphei Veng near Shija hospital Imphal more than 10, years from now renting two semi pucca building, one building used for residential home other building was used fare running a beauty parlor my daughter Linda Talien professional is beautician and she ran her beauty parlor the another pucca building.
2. The communal riot on 4-5-2023 at about 10.00am me and my family fled from our house in order to save ourselves from the wrath of the mobsters, and took refugee camp at 2nd Manipur Rifle Imphal, by taking with us only our wearing apparel, on the same day about 2.00pm, a mob organized a huge around come at Vaiphei Veng and started to burn our area building.
3. That me and my family could not lodge the report in time due to the warlike situation, as such, there is same delay in the falling the present report and your good-self my register the belated report as a F.I.R case hence, the petition.

In the light of the a foresaid fact circumstances, your good-self way graciously be pleased to register F.I.R in the regard.
