With due respect, I have to state a few lines for your kind consideration and necessary action. I am a driver by profession and I drive a TATA Di bearing Reg. NO. ML04B 6703 and deliver water to houses since May 2023. Today i.e. 28th Nov, 2023 at about 9:00 am, I was returning in the said vehicle to Langol Laimanai water refilling centre along with my wife and my daughter after water delivery at Kombirei Car wash at Sanakeithel. On reaching along the road between Kendriya Vidyalaya No. 1 Lamphel and CAU Lamphel Office, my vehicle was blocked by one Mahindra Quanto bearing Regd. No. MN01G 5141. Immediately, four unknown masked persons got down and threatened us using double barrel. They forcibly took away our vehicle, TATA DI and we three were forced to sit in their Mahindra Quanto. Thus, we were dropped in front of Pari Imom Sindam Sang, Langjing. They took away my JIO Sim bearing No. 9863743213. You are therefore requested to take necessary action to recover the said vehicle.
