

Subject:- Report.

Sir,

I have the honour to state that today i.e., 28/11/2023 at about 02:30 pm, received a reliable information regarding transportation of illegal drugs in a Tata Super ACE at Ghari Makha Leikai area. Based on the information, a team of CDO-IW led by Shri Md. Riyajuddin, MPS, (Addl.SP), Dy.SP(Ops.)IW (Gazetted Police Officer) and myself under the command of Shri M. Amit Singh, MPS, Addl.SP(Ops.)IW and under the overall supervision of Shri. Ksh. Shivakanta Singh, IPS, SP-IW rushed to the said area. Later on, Executive Magistrate namely Aribam Devakishwar Sharma, SDC, Hiyangthang, Imphal-West arrived at the said area after requisition and conducted frisking and checking at Ghari Makha Leikai near Mahindra Showroom. During that one Tata Super ACE was seen coming from Changangei side towards our frisking zone and the said Tata Super ACE was stopped for checking at the spot. On checking the said Tata Super ACE red in colour bearing Registration No. MN02B5298, one driver and occupant were found and they were detained for spot checking and verification. During spot verification, the driver identified himself as Md. Tarique Ahamed (33 yrs) S/o. Md. Siraj Ahamed of Lilong Haoreibi Leihakhong (driver of Safe Express Courier Service) and occupant identified himself as Md. Imtiyas Khan (25 yrs) S/o. Md. Satar of Lilong Tolen Khun (Labour). One OPPO F19 Pro + mobile handset along with one JIO SIM card bearing no. 89918650400008681670 (Phone no. 7005175989 as disclosed by him) and one Aadhaar card were recovered from the possession of Md. Tarique Ahamed.

Further, the police team along with the above mentioned Executive Magistrate checked the Tata Super ACE. During that some boxes labeled with "PRODUCT NAME:- CODEDYL-CT COUGH SYRUP" were found. On opening one of the boxes in presence of the witnesses including the above mentioned Executive Magistrate and Gazetted Police Officer, 160 nos. of CODEDYL-CT cough syrup 100 ml bottles containing Codeine Phosphate IP 10 mg per bottle were found. On enquiry the driver and occupant of Tata Super ACE they disclosed that the above mentioned boxes is to be delivered to one Makakmayum Apikcha (aged about 45 yrs) (Ph. No. 9862163539) S/o. (L) Makakmayum Angoubi of Lilong Leihakhong is carried out from the Safe Express Courier Service located at Mantripukhri Khabam Lamkhai and confirmed that this COUGH SYRUP consignment was coming in the name of M/S SK ENTERPRISE, CHINGMEIRONG DINKU ROAD, KHONGNANGANI KARAK, IMPHAL EAST, MANIPUR - 795010 and he produced an WAY Bill number 100008774436 in this regard. On further opening of the remaining 18 nos. of boxes, similar cough syrup bottles were also found, each box containing 160 nos. and 1 box containing 120 nos. of CODEDYL-CT cough syrup 100 ml bottles containing Codeine Phosphate IP 10-mg per bottle. Therefore, a total 20 nos. of boxes containing 3160 bottles of CODEDYL-CT cough syrup 100 ml containing Codeine Phosphate IP 10 mg per bottle were recovered from the spot.

Hence, the above recovered articles along with the above mentioned WAY Bill number 100008774436, 20 nos. of boxes containing 3160 bottles of CODEDYL-CT cough syrup 100 ml containing Codeine Phosphate IP 10 mg per bottle and Tata Super ACE red in colour bearing Registration No. MN02B5298 were seized from the possession of Md. Tarique Ahamed at the spot at 03:10 pm and arrested Md. Tarique Ahamed and Md. Imtiyas Khan at the spot at 03:30 pm and at 03:40 pm respectively by observing formalities.

Hence, the arrested persons and the seized articles are handed over to you for taking further necessary legal action against them.
