Subject: Request for taking legal action against Shri Wahengbam Pitaranjit Singh particulars noted below.

With due regards, I the undersigned have the honour to state a few lines for your Sir. kind consideration & needful action:

That, on 18/11/2023 at about 03:00 PM, my daughter Lairikyengbam Nutun Devi (24) has went out from the house & did not returned back. My daughter is currently undergoing medical treatment because she is suffering from depression & is still taking counselling from different doctors & hospitals like "Leitarashi Pukning Wakhal" & "Shija Hospital" etc. After 2 (two) days i.e on 20/11/2023, I came to learnt that my daughter had eloped with Shri Wahengbam Pitaranjit Singh (32) S/O (L) W. Ibochou Singh of Hiyanglam Terapishak, PO & PS- Kakching, Kakching District, Manipur, who serve in Manipur Police Department as Constable.

That, Shri Wahengbam Pitaranjit Singh is married & has 2(two) children, yet due to the deep attachment between my daughter & Shri Wahengbam Pitaranjit Singh, both of them had eloped earlier also. Because of which, I have already discussed with the elders of Shri Wahengbam Pitaranjit Singh's family that my daughter is currently under medical treatment and after the treatment is completed, wedding day of both will be decided. But despite this, our family is facing embarrassment again and again in front of the society due to this repeated elopement & taking away my daughter secretly from my house by Shri Wahengbam Pitaranjit Singh in collusion with some of his associates. We have requested Shri Wahengbam Pitaranjit Singh's family several times to bring my daughter to my house as per our customs (Nupi haidokpa) so that this time both of them can get married on an auspicious day. But like before, this time also Shri Wahengbam Pitaranjit Singh's family has not come to our house even after several days which should be done as per our customs.

That, we were able to have a phone conversation with my daughter, on which my daughter told us in a very low voice, secretly & very scared that Shri Wahengbam Pitaranjit Singh's family members will not go to our house under any circumstances & will keep my daughter to their house without marriage. The way my daughter was talking on the phone, I had a lot of doubt about what condition she would be in. Our family was ready for the marriage but which family would want to keep their daughter in a house without marriage or ritual rites.

That, on 27/11/2023, I along with my daughter Lairikyengbam Nutun Devi's elder brother Lairikyengbam Okendro Roy went to Shri Wahengbam Pitaranjit Singh's residence and came back home with my daughter. During which my daughter told us that whenever, she talks to her elder brother Lairikyengbam Okendro Roy on phone. she always get beaten by Shri Wahengbam Pitaranjit Singh.

You are therefore, requested kindly take appropriate legal action against Shri Wahengbam Pitaranjit Singh.

We could not file the complaint report on time because we thought that Shri Wahengbam Pitaranjit Singh's family would definitely come to our house as per customs.
