After looting all the moveable properties and cash including one Car bearing regd. MN01 AW 0240, Furnitures, Electronic items. Utensils Clothes, Books, Important Documents, food and grains etc. leaving us homeless. The approximate value of lost property is calculated at about Rs. 5,00,00,000/- (five crores).

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
