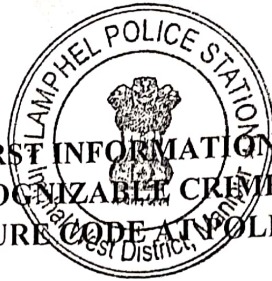

Sir,

I have the honour to state that, on 04-05-2023 at around 3:15 pm some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1000-1500 persons carrying sophisticated weapons like AK Rifles, SLR, INSAS and .303 Rifles, forcefully entered our locality Khongsai veng, Laipham Khunou, Khongsai veng about 42 Km South from Saikul-PS. After looting all the moveable properties and cash including one Car bearing regd. MN01 AW 0240, Furnitures, Electronic items. Utensils, Clothes, Books, Important Documents, food and grains etc. leaving us homeless. The approximate value of lost property is calculated at about Rs. 5,00,00,000/- (five crores).


It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
