Sir,

I have the honour to state that, on 04-05-2023 at around 11:30 am some unknown miscreants suspected to be a members of Meitei Youth Organisations, Meetei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 600-700 persons carrying sophisticated weapons like AK Rifles, SLR, INSAS and .303 Rilfes, forcefully entered our locality at Langol Housing Complex, about 52 Km South from Saikul-PS. They looted all the moveable properties and cash and burnt down all the remaining household items including, 1 x Two wheelers bearing No. MN 01AF 0038 and 1 x four wheelers MN 01 AG 0442, Furnitures, Electronic items, Utensils, Clothes, Books, Important Documents, food and grains etc. leaving us homeless.

The approximate value of lost property is calculated at about Rs.70-80 lakhs.

It is, therefore, requested you to kindly registered a regular case and take necessary legal acon against the culprits according to law.
