Subject : Report.

Sir,

I have the honour to state that, on 4/05/2023 at around 3:15 pm some unknown miscreants suspected to be members of Meitei Youth Organisations, Meitei Leepun, Kangleipak Kanba Lup (KKL), Arambai Tenggol and World Meitei Council (WMC), Schedule Tribe Demand Committee (STDC) numbering about 1500 persons carrying deadly weapon and fire arms, forcefully attacked our locality, Khongsai Veng, Laipham Khunou, Imphal East, about 42 km South from Saikul-PS, and they vandalised, damaged and looted all the moveable and valuable properties and burnt down my rented house alongwith the remaining household properties. Fearing lost of lives I left my rented house and fled to nearby safe location at 2<sup>nd</sup> MR Bn and later evacuated to Kangpokpi District with the help of Central Security Force.

The list of properties destroyed or loss are mentioned in the annexure (enclosed). The Approximate value of the loss properties is calculated at about Rs. 2,55,100/- (two lakhs fifty five thousand and one hundred).


Due to lack of legal knowledge I could not report the incident timely to the concerned authority.

It is, therefore, requested you to kindly registered a regular case and take necessary legal action against the culprits according to law.
