

Subject : Report.

Sir,

I have the honour to state that, with the sudden outbreak of communal conflict between Kuki and Meitei Community in Manipur on 3rd May 2023, some unknown miscreants belonging to Meitei community started hunting the Kuki settlers in the Imphal valley. That, I am a residence of Chingmeirong, Lei Ingkhol near Chingmeirong cemetery, Imphal East District, Manipur about 43 km South from Saikul -PS. and the violent mob numbering in thousand deliberately attacked the Kuki Settlers in the Imphal valley. Fearing lost of life and to avoid any circumstances from the enraged mob I fled for my life to a nearby safe location and leaving behind all the household properties, furnitures, electronic items and many other valuable items etc.


Further, It is learnt that, on 10-05-2023 at around 11:00 pm some unknown miscreant suspected to be belonging to Meitei community broked into my residential house and they vandalized and looted all the moveable and valuable household properties including domestic animals, and totally dismantle my house leaving us homeless. As of now I am staying at my relative house at Tusam Village Saikul, Kangpokpi District, Manipur.


The list of properties destroyed or loss are mentioned in the **Annexure (enclosed)**. The Approximate value of lost properties is calculated at about Rs. 55,34,000/- (Fifty five lakhs thirty four thousands).

Due to lack of legal knowledge and some personnel problems I could not report in time.

It is, therefore, requested you to kindly register a regular case and take necessary legal action against the culprits according to law.
