It has come to my knowledge that on 3rd May 2023 at around 11:00 pm, unknown miscreants suspected to be Meetei community, Arambai Tenggol, Kangleipak Kanba Lup, Meetei Leepun numbering about 1000 attacked my two houses at National Games Village, Immanuel Colony, Zone-1 bearing Patta no. 30/3425, Daag No. 51/900. They looted and destroyed my one storied pucca house and burnt down my single storied semi-pucca house. The value of all our properties which has been looted, destroyed and burnt is estimated to be around Rupees 2 crore (Rs. 2,00,00,000) only.

I, therefore, request you to kindly take up necessary and just action regarding this irreparable and unlawful situation.
