Subject: Complaint Report

Sir,

With due respect and humble submission, I beg to state that on 03 June 2023 at around 4:00am, some unknown miscreants armed youth suspected to be Meitei Militants assisted by Meitei Youth organization; ArambaiTenggol, Meitei leepun and Kangleipak Kanba Lup (KKL) numbering about 1000 member, carrying sophisticated weapons forcefully entered my colony, Langol Housing Complex, PO Lamphel, PS Lamphel, Imphal West District, Manipur. As a result, they vandalized my house (Government Quarter) Langol Housing complex type II, House No B-14 and looted all the valuable household properties.

The details of the properties looted or loss are as follows: Almirah large wooden (5 x Rs.80,000), Sofa set seater with cushion (3 x Rs. 82000), Sofa Table set with glass top (2 x Rs. 30,000), Wooden Bed box (2 x Rs. 28,000), Washing machine (Rs. 18,500), Refrigerator (Rs. 32,700), Large wooden bed (Rs. 3 x Rs. 70,200), Electric Oven (Rs. 11,600), Sintex (1000 L) (3 x Rs. 7000), Kitchen utensils (Rs. 90,000), Clothings (Rs. 1,50,000), Blanket silk and cotton (14 x Rs. 29,000), Gas cylinder and cards (Rs. 26,100) Stove automatic and 5 burners (Rs 7600), Cycle with gear (2 x Rs 33,000), Traditional dresses (Rs. 21,000), Children toys and electric automobiles (Rs. 35,000), Wifi Router (Rs. 3,500), Well (Rs. 29,000), Extended room (Rs. 80,000), Framed photos (Rs. 10,500), Water pump (Rs. 4,500), Steel rack (Rs. 5 x Rs. 16,000), Important Documents, Books and Certificates (Rs. 10,000), Dining table with chair and cushion (Rs. 45,000), Dressing table (Rs. 32,000), Smart TV (Rs. 52,000), Sony home theatre (Rs. 17,000).

The total estimated value of loss properties is approximately Rs. 10,51,200 (Rupees Ten Lakhs Fifty one thousand and Two Hundred)

Therefore, I request you to kindly register the case and take necessary action according to law.
