I, the undersigned would like to lay down the following facts before you to take necessary action

That following ethnic violence between Meitei and Kuki Zo communities from the 3<sup>rd</sup> night of May, 2023 I and my family on  $4^{th}$  May '23 morning left our old Maruti car at a one of my neighbour's house compound at Meitei leikai adjacent to E/III Sector of Langol housing complex and rushed to the nearest relief camp at CRPF Lamphel. From there on 9<sup>th</sup> May 2023 we were later escorted to T. Chaljang village, Kangpokpi dist. Manipur.

After 4 months of the violence situation still on the run. On 24 September 2023 my neighbour M. Dhiren Singh to whom I entrusted my car told me over phone that the car had gone missing while he was out of station for medical treatment at Guwahati. The where about of the car is not known till today.
