Sir,

I, the undersigned would like to lay down the following facts before you to take necessary action.

That on the 3<sup>rd</sup> night and 4<sup>th</sup> May, 2023 unknown miscreants belonging to Meitei community numbering more than 1000 people suspected to be members of Arambai Tengol and Meetei Leepun and others with deadly weapons attacked, ransacked, looted and burnt down houses of Kuki Zo community at our place Phaipijang Langol, Lamphel Sub. Division Imphal. The following day 4<sup>th</sup> May '23 as there was no action from the Govt. for protection we had to leave our Langol home and rushed to CRPF Lamphel, Imphal and thereafter on 9<sup>th</sup> May '23 we were escorted to T. Chaljang village Kangpokpi dist and are staying here till today. During the course of this ethnic violence situation on 4<sup>th</sup> Sept. '23 one of my neighbours there reported to me that my house were openly broke through by mob and looted all the properties inside it. My house was not burnt at the time of reporting. The house is a 2 storey one at Spring villa, Phaipijang Langol, Imphal and its location being ECA church in its south and CTS school in its east. The details of properties loss are as below:

1-Teak beds 2 nos. (Rs.1.23 Lakh), 2 - Mattress 2 nos.(Rs.96K), 3 - Mattress 3 nos. (Rs.66K), 4 - Leather coach 2 sets (Rs.2.33Lakhs), 5 - Leather sofa 3 seater (Rs.42K), 6 - Teak centre table (Rs.12K), 7- Centre table (Rs.11K), 8 - Dinning table 6 seater (Rs.60K), 9 - Samsung big door Fridge (Rs.93K), 10- Micro wave Oven (Rs.75K), 11- Flat TV M.I 52"(Rs. 42K), 12- Curve TV M.I 42 " (Rs.40K), 13- Clothes etc (Rs.60K)

**Total loss of Properties is estimated to be about Rs. 8,74,200 (Eight lakhs seventy four thousand two hundred) approximately**

That I could not report the incident to my concerned police station as we were on the run and no longer has access to Imphal. I therefore request you to take necessary action at your end. For this I shall remain grateful to you.
