Sir,

On the 28<sup>th</sup> of May, 2023 at around 3:30 pm, thousands of Youth suspected to be 'Arembai Tenngol' group from Meitei community, using sophisticated weapons attacked our rented house at the residential house of Mr. Sumthou Hmar, House No. 56 located near Super Market, Lamphel, Imphal West District, Manipur. So, I and my family fled from our rented and hid in different places to save our life. On that same day, after we fled they had destroyed the locked door, looted every pieces of our properties.

I therefore requested to book the culprit and take necessary action as per the law of land.
