A/P Lamphel Sanakeithel lodge a complaint report to OC/LPS on 21/05/2023 stating that she parked her Car B/Reg No. AS01EH1314 in front of Kendra Vidyalaya Central school and was compelled to stay at 86 Bn CRPF Camp due to public riot since 4<sup>th</sup> May 2023.
