I the undersigned would like to submit this complaint regarding looted and destruction of my properties including Computer Centre and Tailoring Centre own by me in a rented house of one Shri Thangsei Haokip at National Games Village Zone-II Near Auto Parking, opposite to St. Peter School on the night of 3rd May, 2023 at around 9:00PM by unknown Meitei miscreants/Mob.

The details of the properties destroyed are listed below:

 2. Yamaha Fascino Bearing Reg. No. MN01AB 1215,
 3. Two (2) Nos. of Desktop and Laptop.
 4. Four (4) Nos. of Printer.
 5. Mini ATM.
 6. Laminator & Paper Cutter.
 7. Two (2) Nos. of Sewing Machine and Overlock machine.
 8. One wooden Bed with Mattress.
 9. One Refrigerator.
 10. One Washing Machine.
 11. One Television along with Jio fiber Router.
 12. One Godrej Almirah filled with clothes.
 13. Cash Two lakhs Twenty seven thousand only (Rs. 2,27,000.000/-)
 14. One Gold necklace worth Rs. 60,000 (sixty thousand only)
 15. One Gold ear ring worth Rs. 25,000 (twenty five thousand only)
 16. Gold ring worth Rs. 17,000 (seventeen thousand only)
 17. Educational Certificate (class 10 bearing Roll No. 26825, class 12 & BA in the name of Lunjahao Chongloi)
 18. Educational Certificate (class 10, 12, BSc. in the name of Hatneiting Haokip)
- The above two mentioned vehicular were burnt down at the residence of one Shri Letsei Haokip of Langol, Hebron Veng opposite to Bake Bee near Oil pump.
However, the vehicular document of Yamaha Fascino which were intact with the vehicle were also burnt down and could not remember the Chassis and Engine Number.

I Request you to kindly register my complaint and look into the matter and do the needful in the interest of justice.
