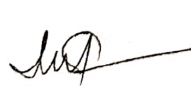

Sir,

I, Mrs. Rimi Kipon of Langle Housing complex Quater no. Type-II-C-13, Imphal west would like to report that I was attacked by Meitei Miscreants led by Nambai Tongol and Meitei Kipon and Quater no. Type-II-C-13 was looted by Meitei miscreants including Nambai Tongol on the 4th May 2023 my family members 1) (L) Serkhapao Miao (Husband) 2) Mr. Pagsalen Miao 35 years 3) Mr. Tongminlon Miao 33 years 4) Mr. Letminthang Miao 30 years narrowly escaped with our lives. List of my looted properties are appended below.

Therefore, I request for immediate action to this effect.
