Sir/Mam,

It is to inform you that on 4th May, 2023 at around 11:00 am, a group of unknown miscreants numbering around more than 500 (five hundred) persons suspected to be of Meitei organization attacked, vandalized and looted my rented apartment at Lanthungchin Gate, Langol, Imphal west in a broad daylight. I have also lost my Indian Passport bearing No. N4809566 (Nengneichong Hangshing).

The approximate total cost of the looted/ damaged properties is around
Total = Approximately Rs. 2709000/- (Twenty Seven Lakhs Nine Thousand) in value as enclosed in the Annexure.

It is therefore, requested you to lodge an FIR in connection with the incident and take up necessary action against the culprits at the earliest.
